

The Hartford, Conn. "Courant" ran a story on May 18, 2022, talking about a demand surge for submarine manufacturing workers in Connecticut. The Navy is at point of considering outsourcing if they can't get the workers they need – and, FAST!

More than 3,000 workers are needed this year, a 20% increase over 2021.

The local Workforce Investment Board in Connecticut has doubled the number of classes from a previous high of 24 to train welding, pipefitting, sheet metal work and other skills.

Here are some ideas being tossed around:

Navy thinkers are looking at the possibility to outsource construction to yards that have not traditionally done naval nuclear submarine work.

## Satellites pick up dolphin activity

USNI NEWS -- Nothing should surprise you, according to USNI News. They report that "Russia has deployed trained dolphins during its invasion of Ukraine to protect a Black Sea naval base."

According to a review of satellite imagery, the Russian Navy has placed two dolphin pens at the entrance to Sevastopol harbor, sheltered just inside a sea wall. The pens were moved there in February, around the time of the invasion of Ukraine.

Why? USNI notes the Russia's most significant naval base (Sevastopol) is in the Black Sea. The dolphins "may be tasked with counter-diver operations." Their task could be to


Navy's 'Get Real, Get Better' initiative

#### **Grateful** Nation

"Thank God, we're part of NATO," because the North Atlantic island nation without an army can no longer "take peace for granted," Thórdís Kolbrún Reykfjörd Gylfadóttir, Iceland's Foreign Minister, said at the Wilson Center in Washington D.C. last week. -- USNI News NAVY.MIL (Monterey, Calif.) – Vice Chief of Naval Operations Adm. William Lescher spoke at the Naval Postgraduate School this month discussing the Navy's "Get Real, Get Better" initiative (GRGB) and how the Navy plans to stay ahead in today's era of strategic competition.

The plan was developed over several years of observing industry leaders outside of the Dept. of Defense (DOD) to improve the Navy's warfighting ability. They studied both commercial airline readiness and technology giants to learn how to get technology and innovation moving forward.

"We've spent the better part of four years thinking hard, with our heads



prevent Ukrainian special operation forces from possible underwater sabotage to many high-value Russian Navy ships docked inside the harbor out of range of Ukrainian missiles.

During the Cold War, the Soviet Navy developed several marine mammal programs, including dolphin training in the Black Sea.

With the collapse of the Soviet Union in 1991, the program transitioned to Ukraine, but attempts to keep it operational were not successful. When the Russians annexed the Crimea in 2014, it again came under Russian Navy control. It appears "the marine mammal programs have been expanded and returned to operational service," they report.

down, quietly learning about how we can make the Navy better," he told the graduates.

The final GRGB structure focuses on:

- "First, the Navy must get real," he said. "We have to self-assess and be our own toughest critics. We need to be honest about our abilities and be fully transparent about our performance. Once we 'embrace the red,' we will be able to identify solutions and more realistically predict our mission readiness."
- "Secondly, we must get better," he continued. "We need to be able to self-correct by continuously fixing small problems at the lowest level before they become a large

**Next meeting** will on June 4, 2022 at Mustangs Bar and Grill, South Beloit, Ill., at noon. (Editor's Note: In February we shared some exciting news for our Wisconsin veterans. This month, we offer some news for Illinois veterans sent to us by Illinois Rep. Andrew Chesney, from the 89th District.)

House Bill 4680. This bill now makes it easier for active-

duty service members and veterans to obtain fishing, hunting, and camping permits. "Until now," he writes, "state code required you

to apply in-person at the Illinois Dept. of Natural Resources (IDNR) region office to provide verification of military service." During COVID-19, those offices were closed.

Thanks to the passage of this bill, veterans and activity duty military no longer must go to a INDR office for proof of verification.

House Bill 2991. This bill, which also passed, will help ensure that all veterans in Illinois have access to the services they need and deserve. It approved an analysis of the availability and adequacy of veteran's services throughout Illinois. It amends the Dept. of Veterans' Affairs Act and dictates that the Dept. of Veterans' Affairs establish a field office in each legislative district. In 18-months, following veteran service questionnaires, surveys, and town hall meetings, the IDV must submit a plan to improve veteran services, including estimated costs.

House Bill 5184. This newly passed bill addresses funding

for local Veterans Assistance Commissions (VACs), who over the last several years have faced litigation regarding VAC funding. Oftentimes, counties believe that VACs are simply a line item under their budget, rather than an independent unit of local government that

requires funding. As such, VACs often go underfunded year after year.

House Bill 557. Students who are dependents of activeduty military

personnel can now enroll in school sooner than previous state law allowed when the family relocates per military orders. The new law requires school districts to allow a dependent of U.S. military personnel to enroll free of tuition if, at the time of enrollment, the child is in temporary housing outside of the school district but will be living within the district within 6 months (not 60 days under the previous law).



issue. We must identify and fix root causes rather than adapting

• to issues that arise. And we need to clearly identify people who are accountable at every level."

During the audience question section, he "reiterated to students that they should be courageous, speak truth to power, and be a driving force forward to make the Navy's processes and assets serve as examples of 'world-class performance.'"







## It's Real: Space Force recruitment growing

(Editor's Note: I share the following excerpt from any article by **Thomas Novelly**, on <u>Military.Com</u>--Apr. 25, 2022). It gives our various veteran regions some food for thought, too.)

"The Space Force has unveiled a wave of bonuses to lure recruits with highly specialized tech backgrounds to become Guardians.

"Bonuses range from \$12,000 to \$20,000 for certain technology certifications that could be



used for the Space Force's cyber career fields, according to a press release from the Department of the Air Force's Recruiting Service.

"Earlier this month, the Department of the Air Force unveiled more than a dozen bonuses as a way to entice new recruits amid a national labor shortage and a pandemic economy.

"But while the Air Force said it's facing headwinds to fill its ranks, the Space Force is having no problem getting recruits into the small number of spots it has, as interest continues to grow in the newest military service branch.

"Maj. Gen. Ed Thomas, the Air Force Recruiting Service commander, told Military.com that last year they had more than 42,000 leads on people interested in joining to fill just 500 spots.

"Space Force recruiting is on very solid ground right now," Thomas said.

"For Space Force Guardians who have already joined the ranks (up to 8,400) . . . is expected to grow by 200 new recruits in 2023. The Dept. of the Air Force is also offering reenlistment bonuses for a dozen careers, such as cyber intelligence analysts and communications specialists, to retain their specialized knowledge and skills.

"Unlike other services, the Space Force does not have a reserve or National Guard component.

"The Space Force will make history next month when 72 men and women start the first "Guardians-only" boot camp at Joint Base San Antonio, Tex."

Since the inception of the Space Force, recruits have gone through Boot Camp with other men and women in San Antonio, Tex. In May the Space Force will have its first book camp class consisting of only future Guardians.

We can't go with Tom's solution: "Put the Marine flag under the Navy flag; after all, they are just a part of the Navy." The local Marines in town didn't like this suggestion.

## Tolling of the Bells for Lost Boats



March

USS F-4 [ex-SKATE] (SS-23) lost on March 21, 1915. Loss of 19 crew when it floundered off Honolulu Harbor. Hulk raised and reburied off Sub Base, Pearl Harbor.

USS H-1 (SS-28) lost March 12, 1920 while being towed after grounding at Magdalena Bay, Mexico. Loss of 4 crew.

**USS Perch (SS-176)** scuttled March 3, 1942 near Surabaya, Java on her 1st war patrol. Depth charges badly damaged the boat. Crew survived sinking: 61 taken prison by Japanese forces, only 53 survived the war.

USS Grampus (SS-207) lost on or after March 5, 1943 in the Blackett Strait--possibly near Vella Gulf. Loss of 71 crew. Believe to be sunk by Japanese destroyers.

USS Triton (SS-201) lost on March 15, 1943 when sunk during a surface attack by three Japanese destroyers north New Guinea, by the Admiralty Islands. Loss of 74 crew.

USS Tullibee (SS-284) lost March 26, 1944 while operating north of Palau. Loss of 79 crew. Believed to be a victim of a circular run by one of her own torpedoes on her 4th war patrol. The only survivor, a lookout, was knocked off the boat with the explosion. He survived the war as a Japanese prisoner. USS Kete (SS-369) lost on or after March 20, 1945 when sunk on return to Midway (probably near Okinawa) at the end of her 2nd war patrol. Loss 87 crew.

USS Trigger (SS-237) lost on March 28, 1945 in the East China Sea. Loss of 89 crew. On her 12th war patrol, this highly decorated boat was involved in operations leading to the Okinawa invasion when attacked by Japanese antisubmarine vessels and aircraft.

## April

USS Pickerel (SS-177) lost April 3, 1943 when sunk of Honshu, Japan. Loss of 74 crew. The exact loss is unknown, but presumed to be as the result of minefields.

USS Grenadier (SS-210) lost April 22, 1943 on her 6th war patrol, when scuttled after serious damage by aircraft near Penang in Indian Ocean. 61 crew taken prisoner by Japanese forces. 57 survived the war.

USS Snook (SS-279) lost sometime after April 8, 1945 when sunk near Hainan Island, China, possibly falling victim to a Japanese submarine. Snook ranks 10th in total Japanese tonnage sunk and is tied for 9th in the number of ships sunk. Loss of 84 crew.

USS Thresher (SSN-593) lost on April 10, 1963 when sunk while on sea trials near Isle of Shoals. The first of a new class of nuclear attack subs, the boat just completed an overhaul and was lost in

(Photo: Navy History & Heritage Command) a drive at test depth in over 8,000 feet of water. Loss of 129 crew and yard workers from Portsmouth Naval Shipyard.

### Мау

USS Squalus (SS-192) lost on May 23, 1939 when it flooded and sank off Portsmouth, NH. Loss of 26 crew with 33 rescued. Boat was raised, overhauled and refitted, then recommissioned as Sailfish.

USS Gudgeon (SS-211) lost on May 12, 1944 when sunk off Saipan near Maug Island in the northern Marianas on her 12th war patrol. Gudgeon was the first US submarine to go on patrol from Hawaii following the Japanese attack on Pearl Harbor and was the first US submarine to sink an enemy warship. Loss of 79 crew.

USS Lagarto (SS-371) lost on or shortly after May 3, 1945 when sunk on her 2nd war patrol off the Gulf of Thailand by a Japanese radar-equipped minelayer. Loss of 85 crew.

USS Stickleback (SS-415) lost on May 28, 1958 when it sank off Hawaii while being towed after a collision with USS Silverstein (DE-534). All crew rescued.

USS Scorpion (SSN-589) lost on May 22, 1968 due to an undetermined cause while in transit from the Mediterranean to Norfolk. She was located five months later 400 miles southwest of the Azores at a depth of 10,000 ft. Loss of 99 crew.
