USS Illinois Base: Who are we?

The most obvious answer is we are a group of US Navy veterans who served on submarines.

Any more than that? Yes. I am glad you asked. Doing a "deep dive" (bad pun intended) through the profiles we provided when we joined this base yielded some interesting observations:

REGARDING THE BOATS WE SERVED IN:

Our members have served on 56 different submarines: (21) **Diesel Boats**; (16) **Fast Attacks** and (16) **"Boomers".**

The oldest boat served on was the **USS Bluefish (SS-222)** commissioned in 1943.

The newest boat served on was the **USS Columbus (SSN-762)** commissioned in 1993.

(3) members served on USS Gato (SSN-615).

(3) members served on the USS Ulysses S Grant (SSBN-631).

November 2022

(2) members served on the USS Barbel (SS-580).

USS Barbel (SS-580) was the lead ship in a class of three; USS Blueback (SS-581) and USS Bonefish (SS-582). Commissioned in 1959, these three boats were the last built diesel electric submarines intended for service. The USS Dolphin (AGSS-555) was commissioned in 1968, but was designed and deployed as an experimental vehicle.

(2) members made **Regulus** missile patrols.

From 1959 to 1964 five **Regulus** boats, (1) SSGN and (4) diesel-powered SSG, provided the first US missile deterrence patrols. These early patrols are qualified for the "Boomer" pin. After the Regulus program was terminated these boats were all repurposed.

(1) member served on the USS Halibut (SSGN 587). The USS Halibut, commissioned in 1960, is oldest nuke served on by one of our members.

USS Halibut (SSGN 587) was specifically designed to carry the **Regulus** missile. After the **Regulus** program was terminated, USS Halibut (SSGN 587) was repurposed and became one of the most noted "spy ships" of the Cold War.

USS Cobia receives large grant from National Park Service

WLUK-Fox News 11 in Manitowoc, Wis. reported recently that the Wisconsin Maritime Museum received a \$500,000 award from the National Park Service as part of their Save America's Treasures grant program. The award will go toward the critical hull maintenance project for the USS Cobia, estimated to cost \$1.5 million.

The restoration effort centers on towing the USS Cobia to Sturgeon Bay for dry docking at Fincantieri Shipyard for necessary hull inspection, they report. The last time the USS Cobia was in drydock was in 1996.

"Historic naval vessels around the country have seen the dire consequences of not conducting regular maintenance on the hull. USS Cobia has been lovingly restored by staff and volunteers here for over 50 years.

With this momentous project, we are ensuring that Cobia will be preserved for another generation," said Wisconsin Maritime Museum Executive Director Cathy Green.

The USS Cobia was launched Nov. 28, 1943, in Groton, CT. It served a total of six war patrols in the Pacific Theater during WWII, sinking 13 Japanese vessels.

In 1970, the USS Cobia was brought to Manitowoc to serve as an international memorial to submariners. In 1986, the Cobia was incorporated as a

Sub Vet groups throughout Illinois have received this message regarding Illinois House Bill 4528 which will authorize the Illinois Secretary of State to issue specialty license plates honoring Illinois submarine veterans.

This bill passed in the House on Mar. 3, 2022. It was then handed off to the Senate on Mar. 4, 2022 where it is still in committee.

We have been following this bill from the start, and I have contacted many House and Senate legislators to express my support for this important piece of legislation. I was very optimistic that it would pass the Senate back during the spring legislative session, but during the closing weeks of session the bill sponsor called me personally and explained that no more license plate bills were going to be voted on before the session ended.

As I later learned specialty license plates for fans of the Chicago Sky, Red Stars, and the Fire, was voted on and passed on Apr. 7, 2022– just before the Spring Legislative session adjourned.

When we enlisted, we raised our right hands and swore to defend the Constitution of the United States against all enemies, foreign and domestic, we didn't expect more than what the Navy promised us for our service: a paycheck and the honor and privilege of serving our country. That being said, I don't think the opportunity to be recognized on a license plate by our home state for our service and our sacrifices for our country is asking too much, especially when professional sports teams take that kind of recognition as a daily perk.

During this upcoming veto session, we need to make sure this bill makes it out of committee and onto the Senate floor for a vote. When it makes it to the floor, this bill should pass on its own merit, as supporting veterans should be a non-partisan issue.

The USSVI Illinois membership can help by flooding the bill sponsor's office with phone calls.

The sponsor is Senator Don Harmon, who also happens to be the Senate President:

His District phone number is 708-848-2002, and his Springfield Senate Office phone number is 217-782-8176.

Tell him you want House Bill 4528 out of committee and on the Senate Floor for a vote, before the Veto Session ends after the Thanksgiving break.

Members can start calling ASAP as all of the senators have voicemail.



Forgotten medals seeking owners

JOURNAL-COURIER (Jacksonville, IL) – The State of Illinois is trying to find eleven (11) Purple Heart recipients, writes David Bauer, editor of the local Jacksonville, Ill. newspaper. As of Nov. 17, 2022 they have found the rightful owners or heirs of seven lost Purple Hearts, but they have 11 more people to locate.

in April 1942, the War Department declared that the modern day Purple Heart would be issued to service members who were killed in action as recognition of their sacrifice. When property is considered abandoned in safe deposit boxes in Illinois, it is turned over to the State Treasurer's Office where an attempt is made to locate the owner. In the case of the medals, several have been in the state's care since the 1990s," Bauer reports.

Making this task difficult is that in many cases they are uncertain when the metal was awarded, and if the name associated with the safe deposit box is the same as the medal recipient. The State of Illinois needs your help in finding the below individuals:

Navy Bean Soup

YEILD: 6-1/4 Gallons or 100 portions, each portion: 1 cup

INGREDIENTS	WEIGHTS	MEASURES	PORTIONS	METHOD		
Beans, white, dry	6 lbs.	3-1/2 qt.		1. Pick over and wash beans.		
Ham stock Home bones		7 gal. 8 bones		 Add ham stock and ham bones. Heat to boiling point; cover and simmer 2-3 hours or until beans are tender. If necessary, add hot water. Remove ham bones. 		
Carrots, shredded Onions, finely chopped Pepper	1 lb. 2 lbs.	2-3/4 cups 4-1/2 cups 2 tsp.		4. Add carrots, onions, and pepper. Simmer for 30 minutes.		
Flour, hard wheat, sifted Water, cold	1/2 lbs.	2 cups 3/4 qt.		 Blend flour and water to a smooth paste. Stir into soup, and cook 10 minutes longer.

If beans are old, soak 3 to 4 hours prior to cooking
 Add salt and additional pepper if desired.

\$25 USSVI National Dues USS Corvina (SS-226) lost on Nov. 16, 1943 on her 1st war patrol when sunk from torpedoes from a Japanese submarine just south of Truk Island (an atoll hosting a massive Japanese naval and air base. Loss of 82 crew.

USS Sculpin (SS-191) lost on Nov. 19, 1943 north of Oroluk Island near Truk. Severely damaged by depth charges after attacking an enemy convoy, the Sculpin continued to fight on the surface. Due to damage, a decision was made to abandon ship and scuttle Sculpin. The CAPT J.P. Cromwell remained aboard fearing that vital information in his possession might be compromised under torture—he was posthumously awarded the Congressional Medal of Honor. Loss of 43 crew; 20 more died as POWs,

USS Albacore (SS-218) lost on Nov. 7, 1944 on her 11th war



patrol, when she struck a Japanese mine will running submerged in the channel between Hokkaido and Honshu. Loss of 85 crew.

USS Growler (SS-215) lost on Nov. 8, 1944 on her 12th war patrol when sunk while attacking a convoy in the South China Sea between Honshu and Hokkaido

USS Scamp (SS-277) lost on Nov. 16, 1944 on her 8th war patrol, when it was sunk east of Tokyo Bay from progressive damage in multiple air and sea attacks. Loss of 83 crew.
